In accordance with the Law of 02.05.2007 relating to the disclosure of major holdings, Cofinimmo announces having received a notification of shareholding from the Group Crédit Agricole with registered offices at 75008 Paris, 48 rue de la Boétie. Following the acquisition of shares conferring voting rights, the Group's shareholding has exceeded the minimum notification threshold of 5 % on 26.10.2016.

The company owns a diversified property portfolio spread over Belgium, France, the Netherlands and Germany, worth 3.2 billion EUR, representing a total surface area of over 1,700,000 m². Riding on demographic trends, its main investment segments are healthcare properties (43 %), offices (39 %) and distribution networks (17 %).
