66 % of office space in the Belliard 40 building let

Video projections on the façade from 01.03.2018 until 09.03.2018

(Re)construction works on the Belliard 40 office building are drawing to an end.

The building is located at the corner of Rue Belliardstraat and Rue de la Science/Wetenschapsstraat, at the heart of the European district in Brussels. It offers 18,753 m² of office space, 202 m² of retail space and 17 apartments. Its bold architecture is the work of architect Pierre Lallemand and the firm Art & Build: its structure is built around a volume that rests on two others, and a transparent, five-storey atrium which unveils an interior garden at the back of the building, visible from Rue Belliardstraat. Part of the building is pulled back from Rue Belliardstraat to make room for a green and open space along the pavement, reshaping significantly the face of this much-travelled urban artery in Brussels. The building is equipped with state-of-the-art technical facilities and is 100 % passive in terms of energy consumption. The total budget for the works is estimated at 44 million EUR.

After having signed leases with CEFIC/PlasticsEurope (15-year lease of 6,737m² as from 01.01.2019) and International Workplace Group (15-year lease of 4,355m² as from 01.10.2018)¹, Cofinimmo is proud to announce the signature of a third lease for the Belliard 40 building: this time with the regulated real estate company Aedifica. Aedifica will occupy 1,357m² in the building for a fixed period of nine years as from 01.06.2018. As a result, 66 % of the office space in Belliard 40 is already let.

In order to mark the end of the construction works, we have scheduled video projections on the façade at rue Belliardstraat from 01.03.2018 until 09.03.2018, between 6:00 PM and midnight.
