# Publication of a transparency notification (article 14, first paragraph of the Law of 2 May 2007 on disclosure of major holdings)

# 1. Summary of the notification

Cofinimmo has received a transparency notification dated 02.07.2019 indicating that the group BlackRock, Inc. with registered offices at 55 East 52nd Street, New York, NY, 10055, USA now holds, by virtue of the issue of shares on 26.06.2019, 4.79% of the voting rights of the company. It has therefore crossed the 5% threshold downwards.
