1. FIRST NOTIFICATION

1.1. Summary of the notification

Cofinimmo has received a transparency notification dated 27.03.2020 from the group BlackRock, Inc. with registered offices at 55 East 52nd Street, New York, NY, 10055, USA. By virtue of the acquisition or disposal of voting rights, the group now holds 4.96% of voting securities and 0.23% of equivalent financial instruments (compared to 5.04% and 0.43%, respectively, during the previous notification dated 19.02.2020).

The group BlackRock, Inc. now holds 5.19% of the voting rights in the company, including the equivalent financial instruments.
