# Publication of a transparency notification (article 14, first paragraph of the Law of 2 May 2007 on disclosure of major holdings)

# 1. Summary of the notification

On 01.07.2022, Cofinimmo has received a transparency notification dated 01.07.2022 from Forever Care-Ion. By virtue of the acquisition or disposal of voting rights, the group now holds 4.97% of voting securities (compared to 6.69% during the previous notification dated 12.04.2021).
