# Cofinimmo adds 4 nursing and care homes to its German portfolio

- Acquisition of four nursing and care homes
- An investment of approx. 61 million EUR
- Starting new partnership with two German operators

The Cofinimmo group (Euronext Brussels: COFB) signed agreements to acquire, under certain conditions, four healthcare sites in Germany, one of which is located in Lower Saxony, two in Baden-Württemberg and one in Hessen. The investment for the four sites together amounts to approx. 61 million EUR. All assets are currently in operation and managed by three renowned operators in Germany.

## 1. The sites

The healthcare sites are located in Lower Saxony, Baden-Württemberg and in Hessen. Together they offer approximately 31,000 m² and 547 beds or assisted-living units. The sites of Bad Dürrheim, Lindenfels and Nienburg are located in residential areas and surrounded by a green environment, while the site of Pforzheim – a city of 125,000 inhabitants – is well located in the city centre, in a mixed use area.

All four sites are within walking distance of public transport (bus or train).

# 2. The transaction

The Cofinimmo group signed, through subsidiaries, agreements to acquire, under certain conditions (primarily administrative), four healthcare sites, one of which are located in Lower Saxony, two in Baden-Württemberg and one in Hessen. The investment for the four sites together amounts to approx. 61 million EUR, real estate transfer taxes included. This amount was already included in the investment estimate for 2022, as published in section 1.9.1 of the press release dated 29.07.2022.

For the Nienburg site, the conditions have already been lifted before 30.09.2022 and this building has already been included in our portfolio. For the three other sites, conditions should be lifted in the fourth quarter of 2022 and the acquisition price will be paid upon the lifting of those conditions.

For all four assets, 'Dach & Fach' lease contracts have been concluded with major operators. The weighted average lease term for those assets is 14 years. The rents will be indexed on the basis of the German consumer price index and the gross rental yield will amount to approx. 5%.

# 3. The operators

Novent is a mid-sized healthcare player founded in April 2022. The management and staff of this private company have decades of experience in the care and support of elderly. They are dedicated to the residents - and their families - of the 16 care facilities, where they offer various types of care services, including home care.

The InCura group is a mid-sized healthcare player in Germany. It promotes self-determination and an active lifestyle for the residents. This includes cultural and recreational events, which are also open to external

visitors. Approximately 945 staff members provide nursing, care and life support in 10 nursing and care homes throughout Germany.
