Publication of a transparency notification (article 14, first paragraph of the Law of 2 May 2007 on disclosure of major holdings)

1.1. Summary of the notification

On 22.05.2023, Cofinimmo has received a transparency notification dated 17.05.2023 from the group BlackRock, Inc. with registered offices at 50 Hudson Yards, New York, NY 10001 USA. By virtue of transactions in voting securities, the group now holds 5.05 % of voting securities and 1.71 % of equivalent financial instruments (compared to 4.95 % and 1.76 %, respectively, during the previous notification dated 24.04.2023).

The group BlackRock, Inc. now holds 6.76 % of the voting rights in the company, including the equivalent financial instruments.

1.2. Content of the notification

The notification dated 17.05.2023 contains the following information:
